Dr. J. Pierre Brunet Coach Award

The Dr. J. Pierre Brunet Coach Award was created in 2006 to recognize the important contribution that coaches make to the competition. This includes preparing teams for months prior to the competition, and guiding them the week of the competition.

We also benefit from new coaches who bring fresh ideas to the table each year.

Each year at the competition, we award the coach(es) from a school who demonstrate excellent mentorship. This award is presented at our Final Banquet.



Richard Outcault Team Spirit Award

The Richard Outcault Team Spirit Award was introduced in the year 2000 to honour the memory of the late Richard Outcault, a former competitor at the John Molson MBA ICC. Richard was a member of the Northeastern University team in '98. Three days before the start of the competition, his father suddenly became terminally ill. However, Richard remained positive, and in accordance with his father's dying wish, he left his father's side to compete in the MBA ICC. In the end, his team took first prize! Richard missed the award ceremony to attend his father's funeral. The story only gets more grim as – in 2000 – Richard succumbed to a rare illness.

Those who knew Richard at the competition, most notably his fellow participants, were in awe of his physical and mental stamina, not to mention his humour, creativity, and positive outlook. He truly cherished the "MBA ICC experience" and embodied the "team player" attitude.

Each year, we honor Richard's memory by awarding a team that demonstrates genuine team spirit and collaboration. The winning team is announced at our Final Banquet.

Jean-Simon Castonguay



Sustainability is an integral part of the John Molson School of Business (JMSB) brand. The Corporate Knights ranked the JMSB MBA as the 12th Greenest MBA program in the world. As the largest JMSB event, it is crucial that the MBA ICC reflect the school's dedication to sustainability.

Last year, we were one of the first events to seek certification as a part of the Sustainable Events Initiative (SEI) project. This project, stemmed from the collaboration of Sustainable Concordia, the undergraduate John Molson Sustainable Enterprise Committee (JSEC) and the graduate John Molson's Sustainable Business Group (JMSBG), and was used along with standards from the Bureau de Normalization du Québec (BNQ), to ensure that we are rising to the challenge. That year, we obtained certification under the JSG's sustainable Event Initiative. Moreover, we obtained level 5 under the BNQ standard, which is the highest level achievable.

this year will seek to build on last year's level 5 BNQ score, looking for new ways to incorporate sustainable initiatives and evaluate itself against the best possible standards.

Our sustainable activities include:

Events - All events during the competition held outside our venue will be within walking distance of Hotel Bonaventure and are accessible by Montreal's underground tunnels or by public transport.

Communications - We will use recycled paper for 100% of our printing needs, and whenever possible, we will replace print-outs by electronic documentation.

Donating Leftover Catering - Whenever possible, we will be sending all untouched catering leftovers to a local charitable organization that will help redistribute these meals to the community.

Composting - We will be composting all of our organic waste throughout the competition week.


